

## **HomeSphere Link East 2025: Dallas - Terms & Conditions**

**REGISTRATION SUBMISSION:** By completing the registration form and submitting the required information, you are applying for consideration to attend HomeSphere Link East. Submission of the registration form does not guarantee acceptance to the event. Confirmation to attend the event will be based on various factors including but not limited to professional role or other event structure qualifications. Upon review of your registration submission, you will receive an update via email.

**PARTICIPATION:** Approved participation entitles the representative(s) to participate in the one-on-one meetings, meals, beverages, and other activities outlined within the event program at the venue selected unless otherwise stated.

**Partial or non-participation:** Should you not fully participate in the appointments and social events during the event, HomeSphere reserves the right to charge your card the airfare, hotel guest room night charges, and \$800 event fee that were billed to HomeSphere based on your participation.

**REGISTRATION FEES:** The first attendee from your company receives complimentary attendance including unlimited meetings at Link East, coach airfare, hotel accommodations, transportation to/from the airport at the event, and provided food & beverage. A registration fee is applicable to additional attendees from your company. Fee includes congruent meetings with first attendee, provided food and beverage, and is not inclusive of travel and hotel costs.

**PAYMENT:** Full payment is due thirty (30) days after confirmation of attendance. If the full balance is not received sixty (60) days before the event start date, participation is subject to cancellation.

**CANCELLATION POLICY:** If I am accepted to attend the event, I understand there is no registration fee for the first person from my company and acknowledge that a significant investment has been made by HomeSphere and sponsors of the event to host my participation. I further acknowledge and agree that a required precondition of my attendance is to provide a valid credit card to hold my reservation, and that this card will not be charged unless one (or more) of the below circumstances occur:

- a) ATTENDEE CANCELLATION AFTER FLIGHT BOOKING: Flights are booked immediately upon application approval and due to ticketing policies, the full fare of the airline ticket and applicable taxes and fees is often retained by you to be used towards a future purchase (less any airline change fees). HomeSphere therefore reserves the right to charge your card the full fare of the booked airline ticket upon cancellation.
- b) ATTENDEE CANCELLATION WITHIN 30 DAYS OF EVENT START: In addition to the airfare ticket cost described above, you may be subject to a \$500 cancellation fee for your hotel guest room stay should your company not provide a qualified substitute that is available to attend the event as your replacement.

CANCELLATION BY HOMESPHERE: HomeSphere reserves the right to cancel any event or to terminate this Contract or Attendee's participation in HomeSphere events for any reason at any time upon written notice to Attendee. Upon cancellation or termination by HomeSphere, HomeSphere's sole liability to Attendee, and Attendee's exclusive remedy, shall be a refund of the Registration Fee paid by Attendee under this Contract for the event(s) in which Attendee is unable to participate due to such cancellation or termination. HomeSphere shall not be held responsible for any consequential loss incurred due to such cancellation.

INDEMNITY: Attendee shall indemnify and hold HomeSphere harmless for and from any damage or loss arising from Attendee's damage of the event venue or any property located on the event venue, or Attendee's injury of any event participant or staff.

LIMITATION OF LIABILITY: Neither HomeSphere nor the event venue shall be liable for any indirect, incidental, special, or consequential damages, or damages for loss of profits, revenue, data, or use, incurred by Attendee, whether in an action in contract or tort, even if HomeSphere or the event venue have been advised of the possibility of such damages. HomeSphere's liability for damages hereunder shall not exceed the amount of Registration Fee paid by Attendee under this Contract.

FORCE MAJEURE: If an act of God, war, terrorist act, government regulation, riot, disaster, fire or other casualty, power interruption or failure, strike or other labor action, or any other circumstance or condition beyond a party's reasonable control makes it illegal, impossible or commercially impracticable for such party to perform its obligation under this Agreement, such party may terminate this Agreement upon written notice to the other party without liability.

MEDIA NOTICE: Please note that photographs and footage will be taken throughout the event. These will be used by HomeSphere for marketing and publicity in our publications, on our website and in social media or in any third-party publication.

CODE OF CONDUCT: Attendees are expected to conduct themselves in a respectful and professional manner throughout the event. Behavior that is disruptive, unlawful, discriminatory, harassing, or otherwise inappropriate will not be tolerated. This includes, but is not limited to:

- a) Harassment, intimidation, or discrimination of any kind based on race, gender, sexual orientation, disability, religion, or any other protected characteristic.
- b) Any form of violence, threats, or disruptive behavior.
- c) Damage to event property, venue, or third-party property.
- d) Excessive intoxication or possession of illegal substances.
- e) Unauthorized commercial activity or solicitation without prior approval.

HomeSphere reserves the right, at its sole discretion, to refuse admission to, or remove, any attendee whose behavior is deemed disruptive, inappropriate, or in violation of this agreement. Removal from the event does not entitle the attendee to a refund of any fees paid, and HomeSphere shall not be held liable for any resulting expenses or damages incurred by the removed party.

By attending the event, all participants acknowledge and agree to abide by these terms. The decisions regarding attendee conduct and removal are final and not subject to dispute.

ENTIRE AGREEMENT: This Contract may not be modified or amended except in writing signed by a duly authorized representative of each party.
